On January 5, 2023, the District Attorney General (DAG) for the 20th Judicial District, Glenn Funk, requested the Tennessee Bureau of Investigation (TBI) investigate an officer involved shooting (OIS) that occurred at Hermitage, Davidson County, Tennessee. The OIS event involved Metro Nashville Police Department (MNPD) SWAT member ASHLEY KENDALL COON. The shooting resulted in CAPPS being struck at least once and after subsequent first aid attempts by officers and medical personnel, he was pronounced dead at the scene. The incident occurred at approximately 2:00 PM in Hermitage, Davidson County, Tennessee.

On Thursday, January 5, 2023, at approximately 2:40 PM Special Agent (SA) James Scarbro received a call from Assistant Special Agent In-Charge (ASAC) Nathan Neese. ASAC Neese advised there was an officer involved shooting that had occurred at in Hermitage and District Attorney General Glenn Funk requested the Tennessee Bureau of Investigation (TBI) to investigate the facts and circumstances leading to the shooting.

SA Scarbro arrived at , Hermitage at approximately 3:18 PM and made contact with Special Agent in Charge (SAC) Joe Craig. Other TBI agents present at that time were SA Andy Vallee and SA Eric Reed. SAC Craig explained that Metro Nashville Police Department (MNPD) representative Lieutenant Brent Gipson reported that the Special Response Team (SRT) had been requested to serve arrest warrants for CAPPS. SA Scarbro learned that Tara Capps, McKenzie Acuff, and Noah Silva were in the home very early Thursday morning (3:00 AM), when CAPPS gathered everyone in the living room and held them at gun point refusing to let them leave or call anyone. CAPPS was reportedly drinking and taking medications and threatening to kill them or anyone who came to the house, but he eventually fell asleep giving them time to leave and go to the police department. SA Vallee obtained copies of the four arrest warrants charging CAPPS with Aggravated Assault and Kidnapping and provided those to SA Scarbro.

Initial reports were that three members of the SRT were at the front door of when CAPPS opened the door and pointed a pistol at officers. The three officers were Officer ASHLEY KENDALL COON, Officer Tim Brewer, and Officer Jason Rader. Officer COON is the officer who fired his weapon. The two victims listed in the arrest warrants (Capps and Acuff) were still located at the police department, and death notification to Tara Capps was completed by MNPD.

At approximately 3:35 PM, SA Chris Houk began taking photographs of the crime scene and officers' uniforms.

At approximately 3:45 PM SA Scarbro attempted to take statements from officers COON, Brewer, and Rader but all three declined until they could speak with their attorney's. Officer's Rader and Brewer agreed to provide limited information to agents processing the crime scene with their attorney present, Jack Byrd, so that agents had an understanding of exactly where the shooting took place and what evidence items may be present and required collection.

At approximately 4:10 PM SA Scarbro collected the rifle belonging to Officer COON for firearms testing. A property receipt was prepared and documented the collection.

At approximately 4:30 PM SA Reed began conducting a neighborhood canvas to collect any witness statements.

At approximately 4:34 PM, SA Houk, SA Vallee, and SA Scarbro began marking and collecting evidence items from the crime scene. After evidence items were marked, the Metro Nashville Community Oversight (MNCO) Board members requested to walk through and see the crime scene. SA Scarbro stood at the edge of the crime scene tape and pointed out evidence items to Jill Fitcheard and MNCO investigators. (Refer to the MNPD crime scene log which documented all who entered the crime scene tape)

At approximately 5:45 PM SA Houk, with assistance from SA Scarbro and SA Vallee, completed processing the crime scene. At approximately 5:50 PM SA Scarbro locked the front door of and released the crime scene to MNPD Officers.

The Tennessee Bureau of Investigation is conducting the investigation into the officer involved shooting that resulted in the death of MARK JASON CAPPS. The investigation is ongoing and is being conducted by TBI Special Agent James Scarbro. All supplemental reports and investigative findings will be forwarded to this case file as they are developed.



On January 6, 2023, at approximately 11:30 AM Special Agent (SA) James Scarbro contacted TRACEY WEST at after he had telephoned the Metro Nashville Police Department (MNPD) advising that he had information concerning this investigation.

WEST explained that he was the former roommate of Jeff Capps who was discovered deceased two days prior to the death of his brother MARK CAPPS. He explained that CAPPS and his brother Jeff had been arguing for a while. According to WEST, Jeff Capps told him that he did not think he had received the inheritance he was supposed to when their father passed away. WEST said he talked to MARK CAPPS after learning of Jeff's death and MARK told him that there was no foul play. WEST claimed that he didn't know the truth and was concerned because he knew Jeff used drugs.

Sometime before Jeff died, WEST said he called to tell him that he and his brother, MARK CAPPS, got into an argument and MARK sent him a video that showed he was holding a gun to his head. According to WEST, Jeff Capps believed his brother MARK CAPPS was going to kill himself. WEST stated that he did not see this video, but Jeff told him about it.

WEST advised that he talked to MARK CAPPS on Wednesday and MARK confirmed that he did send a video of him holding a gun to his head to his brother, but it was because he wanted to show his brother, JEFF, "realism" because that is what Jeff understood.

According to WEST, a woman named Colene Walters contacted him via social media and told him that she saw guns and knew MARK CAPPS was threatening to kill himself. She claimed to have had a screen shot from MARK early Thursday morning. WEST advised that he did not know Walters and had never met her before.

On January 6, 2023, Special Agent (SA) James Scarbro responded to the Davidson County Medical Examiner's Office located at 850 R.S. Gass Boulevard in Nashville, Tennessee. The purpose of this visit was to attend the autopsy of MARK JASON CAPPS. The doctor performing the autopsy was Dr. Shannon Crook. The autopsy began at approximately 12:35 PM.

Dr. Crook's preliminary assessment noted superficial injuries and what appeared to be three gunshot wounds on CAPPS. Two gunshot wounds were located on upper left chest area and one in the lower chest upper stomach area. Finally, Dr. Crook noted some superficial injuries and after asking SA Scarbro questions concerning the scene, she surmised they may have been caused by the glass from the storm door during the shooting. Dr. Crook recovered three projectiles during the autopsy.

Dr. Crook advised that her preliminary cause and manner of death would be pending more investigation at this point. The autopsy was concluded at approximately 1:30 PM.



On January 5th, 2023, at approximately 4:19 PM, Tennessee Bureau of Investigation (TBI) Special Agent (SA) SA Kendall Henderson interviewed TARA CAPPS and MCKENZIE ACUFF at the Metropolitan-Nashville Police Department (MNPD) Family Safety Center located at 610 Murfreesboro Pike in Nashville, Tennessee. Also present were MNPD Sergeant Door and various victim services personnel. The interview was audio recorded and a copy will be provided to the District Attorney's Office upon request. After proper identification and explanation of the purpose of the interview, TARA CAPPS voluntarily provided an audio recording. The following is a synopsis of that interview:

TARA was advised that TBI Agents would like to obtain consent to search the shared residence of her and her husband, MARK CAPPS. TARA nodded her head yes and asked that Agents do not take her firearms. SA Henderson advised that she has not been to the scene but gave TARA the opportunity to describe her personal firearms. MARK's vehicle is a gold Chevrolet Impala. SA Henderson read the consent to search form aloud prior to having TARA sign it. TARA indicated any firearms in the master bedroom closet were hers. MARK had three firearms in the bottom drawer of the white nightstand on the far-left side of the bedroom. TARA indicated MARK was using a black Taurus Judge and a silver semiautomatic pistol during the incident. TARA did not recall seeing the silver pistol prior to the incident.

MARK has been very depressed over the holidays, starting around Thanksgiving. He normally becomes depressed around Christmas time. His parents passed away a couple of years ago which was very difficult for him. MCKENZIE stated he was taking Ambien, Xanax, possibly some pain killers and mixing them with alcohol which causes him to become very angry. They've never seen his anger escalate to this extent.

MARK struggled with depression to the point where he didn't care for anything. His brother was discovered deceased on January 3rd, 2023, a short distance from their residence. MARK and his brother did not get along, but MARK felt his brother's passing was more difficult to grieve than his father's. TARA tried to be supportive of MARK while he was grieving.

Last night, MARK began drinking beer. They don't keep beer in the house because MARK is an alcoholic and becomes mean when he drinks. He bought beer yesterday and drank it in front of TARA. She took it away from him and began pouring it out. MARK took several pills with beer before TARA took it away.

TARA and MCKENZIE stayed up until around 2:00 AM. TARA went to bed and found MARK awake in their bedroom. MCKENZIE was upstairs with her boyfriend, Zachery Noah Silva, who works for TBI. MARK got out of bed in the dark and began rummaging through the nightstand gun drawer where he had recently put three pistols. He ensured they were loaded. She turned on the bedroom light and asked what he was doing, to which he responded with the same question.

TARA became afraid and went to the living room and MARK followed. He began making noise in attempt to wake up MCKENZIE and Zachery. MARK was ranting about everything he was depressed over and everything that caused him to feel negatively. He was upset about his brother dying even though they did not get along. He was angry he and TARA did not have sex on Christmas Eve. MARK told TARA she was not being a good wife and gave her the options of being a good wife or calling the police. TARA explained that calling the police meant that everyone would die because MARK would kill everyone in the house and the police that respond. MCKENZIE was able to record portions of the incident with her phone.

MARK went to the bedroom and came back into the living room with a pistol. He sat it down beside him before picking it back up and pointing it at the dogs, TARA, and MCKENZIE. Zachery was still in bed but was listening to what was going on. MARK placed the gun against the dog's head. TARA and MCKENZIE pleaded for their lives. He continued ranting and claiming that he pays for everything, no one cares about him, and that TARA is too lazy to turn the home security system on. Eventually, he brought in another pistol and explained he would shoot Zachery first, TARA, MCKENZIE, and the three dogs, in that order. MARK said he would also kill any police that respond before killing himself.

Eventually Zachery came downstairs, and MARK ordered them to sit down in front of him. MARK continued threatening to kill them all. MCKENZIE attempted to deescalate the situation and continued to beg for their lives. MARK was unaffected.

This continued until around 5:30 AM. MARK went to their bedroom and TARA went with him. She thought he was going to go to sleep, but he verbally abused her and called her names for a few more hours. TARA knew she was going to file for divorce because she couldn't continue to live this way. MARK continued taking medication and drinking alcohol. He passed out around 8:15 AM. Zachery snuck out of the house around 6:00 AM and went to work. TARA stated she knew Zachery confided in people that he worked with at TBI.

Around 8:15 AM when MARK fell asleep, TARA and MCKENZIE grabbed a few things and their three dogs and left the house. They went to MNPD Hermitage Precinct and filed the complaint to have him arrested. It took some time to obtain the warrant.

Zachery has only worked for TBI for about six months. He was also a victim of the threats. TARA provided the code to the front door of their residence. TARA and MCKENZIE provided their telephone numbers.

Zachery entered the room at the conclusion of the interview and provided his telephone numbers.

The interview was concluded at 4:46 PM. The information above is meant to be a summary only

On January 6th, 2023 at approximately 2:33 PM, Tennessee Bureau of Investigation (TBI) Special Agent (SA) James Scarbro and SA Kendall Henderson interviewed ZACHERY SILVA at TBI Headquarters located at 901 R.S. Gass Boulevard in Nashville, Tennessee. Also present were Silva's supervisors, Special Agent in Charge (SAC) Michael Frizzell and Sergeant Joseph Worthington. The interview was audio recorded and a copy will be provided to the District Attorney's Office upon request. After proper identification and explanation of the purpose of the interview, SILVA voluntarily provided an audio recording. The following is a synopsis of that interview:

SILVA was informed the TBI was requested by the District Attorney's office to investigate the officer-involved shooting that occurred **constant and the second seco**

SILVA is not related to the family. He met his girlfriend, Mollie McKenzie Acuff, in college at the University of Tennessee in Chattanooga in 2018. They've been in a relationship for around five years. He lived at the above-mentioned residence for a couple of months, September of 2022 through October 2022, before buying a house in Lebanon. He was staying the night at the residence because McKenzie was in town from Seattle, Washington. They stay there approximately three to four nights a week due to the proximity to his work. Tara Solomon Capps is McKenzie's mom and CAPPS is McKenzie's stepfather, not her biological father. CAPPS produces music for a living. Tara works from home, possibly for BlueCross BlueShield.

The evening of January 4th, Tara, McKenzie, and SILVA attended a gathering at Tara's best friend's house. They were there for about five hours. They left the house around 4:30 PM and arrived at the gathering around 5:30-6 PM. CAPPS did not attend this event. He doesn't go to social events unless he initiates the plans. They returned home around 9:45-10:00 PM. The three of them watched TV on the couch. Around 10:20 PM CAPPS came out of his bedroom to get a beer. He is an alcoholic and SILVA hadn't seen him drink in the last five years. CAPPS bought beer while the three of them were attending the gathering. Tara said he had taken Ambien, Hydrocodone and Xanax. Tara asked him not to drink while taking the medication. CAPPS became upset when Tara poured out the beer and went to his bedroom which is just off the kitchen. SILVA went to bed after CAPPS went into the bedroom around 11:00 PM. He went to sleep and was awakened around 1:30-1:45 AM.

McKenzie was moving around in the bedroom which woke him up. McKenzie and SILVA sleep in the upstairs bedroom. He heard banging downstairs and could hear Tara say something to the effect of "Why do you have the guns". He got dressed and put on his glasses and continued to listen. He did not immediately involve himself. Around 2:00 AM McKenzie exited the bedroom and stayed at the top of the landing which overlooks the living room. SILVA continued to listen.

He could hear CAPPS say something about the alarm system and drug dealers. CAPPS's brother died a few days prior. He said he was trying to protect his family. SILVA has never seen him act this way or even yell before. Shortly after 2:00 AM things went quickly downhill. SILVA stayed in the bedroom and listened because CAPPS told Tara he wanted to shoot SILVA first since he would try and protect McKenzie and Tara. They were yelling back and forth about the alarm system, and the argument continued to escalate. CAPPS swayed from the alarm issue to marital issues. CAPPS accused Tara of having a sexual relationship with SILVA because she laughs at SILVA's jokes and not his. He told McKenzie to wake SILVA up unaware that he was already listening. SILVA overheard CAPPS tell McKenzie that if SILVA contacted law enforcement that everyone would die. CAPPS told Tara that she had three options; She could act like a wife, call the police, or everyone would die that night. At one point CAPPS told Tara and McKenzie that he was going to shoot SILVA first, McKenzie, Tara, the dogs, and himself in that order. He further stated that if the police responded he would shoot them before he shot himself.

McKenzie remained at the top of the landing talking to them, trying to calm CAPPS down. SILVA remained in the bedroom listening. CAPPS and Tara normally sleep together but sometimes she will sleep on the couch. SILVA hadn't seen the guns at this point but did hear statements made that suggested CAPPS had guns. SILVA recalled hearing the revolver being cocked back. SILVA also recalled hearing McKenzie and Tara terrified when CAPPS pointed the guns at them. SILVA heard them make statements such as "Jesus, please don't shoot us". CAPPS continued to ask if SILVA was awake and reiterated that if he saw lights or sirens, he would shoot them.

Eventually, CAPPS directed Tara to tell SILVA to get dressed in his uniform and come downstairs. SILVA stated in the interview, "His exact words were 'Before I wanted to be a fucking hero to let him know not to do anything, otherwise everyone is going to die,'." The arguing continued and CAPPS began throwing objects. SILVA believes CAPPS was trying to wake him up and elicit his response.

SILVA turned off his morning alarms to prevent CAPPS from realizing he was awake. Around 4:10-4:15 AM CAPPS told McKenzie to wake SILVA up within ten seconds or CAPPS would wake him up himself. McKenzie came up and SILVA placed his gun on the ground outside the studio room. Where SILVA was standing, he could see into the living room, but CAPPS wouldn't have been able to see him. He placed his gun on the floor so that if CAPPS ambushed him with gunfire, he could quickly access his gun and return fire. He went to the top of the stairs and saw CAPPS had a silver semiautomatic pistol and a black revolver. CAPPS said, "Look who it is, it's the most important person in the house" to which SILVA responded, "That's not true Mark, this is your house." CAPPS instructed SILVA to come downstairs and ordered the three of them to sit in front of him, and that there were things they needed to discuss. SILVA responded that he was not going downstairs while CAPPS was holding the guns. CAPPS insisted and SILVA again declined. CAPPS pointed a gun at one of the dog's head and told SILVA that if he didn't come downstairs that he was going to shoot the dog. SILVA again said if CAPPS put the guns down,

he would come downstairs. CAPPS set the guns down beside him. After SILVA had sat down in front of him, CAPPS began waving the guns in their direction and towards the dogs.

Tara, McKenzie and SILVA tried to deescalate the situation. CAPPS continued making statements that he felt unappreciated. After a while CAPPS unloaded the revolver which he said was out of respect for SILVA but refused to unload the semiauto as "insurance" so they wouldn't call the police. The pistol laid next to CAPPS. Five cartridges were ejected from the revolver, believed to be a Taurus Judge, and handed to SILVA. Eventually CAPPS asked for the cartridges back. SILVA handed him back four cartridges because one had fallen on the ground. They began searching for the fifth cartridge. CAPPS said if they didn't find the fifth cartridge in the next minute he would begin shooting. They found it and returned it to CAPPS, and he reloaded the revolver.

CAPPS stated that Tara loved the dogs more than him. Near 5:00 AM, CAPPS began asking SILVA what he would do if he put a gun to McKenzie's head. SILVA stated that he wouldn't do anything. CAPPS asked if SILVA had his gun and taser which SILVA replied were upstairs. CAPPS asked what SILVA would do if he allowed him to retrieve his gun and taser, to which he replied he wouldn't do anything because he believes CAPPS is a good man. SILVA told CAPPS he was a good man and wasn't like the criminals on the street. He further stated that he knew CAPPS wouldn't do anything to harm someone he loves. SILVA continued to try and boost CAPPS' self-esteem.

CAPPS indicated he was going to put the guns away in the bedroom and asked SILVA if he wanted to accompany him. SILVA declined and said he trusted CAPPS. When he returned, he asked SILVA to pat him down to which SILVA checked his waistband and found no weapon. When CAPPS went to the bedroom, SILVA asked Tara and McKenzie if they wanted him to call the police. They both said no. SILVA figured that if police responded CAPPS would shoot them.

CAPPS sat back down and continued ranting until about 5:30 AM. CAPPS said his career was the worst it had been since 9/11. CAPPS' brother whom he did not get along with died a few days prior. CAPPS indicated to them that his brother's death was more difficult for him than his dad passing away. He travelled to Norway and struggled to sleep. He returned to the United States and his blood pressure was high. He has been taking medicine but feels like he can't do anything. He believed his music was garbage. CAPPS was supposed to go on tour with The Isaac's gospel group, but the lead singer was in a car accident the tour was cancelled, leaving CAPPS without work. He continued to say Tara didn't love him and was using him for his money.

Just before CAPPS went to bed, he asked SILVA not to report the incident at work. SILVA told him he wouldn't do that and made CAPPS believe he didn't have any power outside of work. SILVA tried to reassure CAPPS he hadn't done anything wrong. As CAPPS went to bed, he stated that he was either going to wake up in a jail cell, he would wake up and everything will be the exact same, or he wouldn't wake up at all. SILVA told CAPPS he was going to work, and CAPPS said okay. McKenzie and SILVA hugged CAPPS and CAPPS and Tara went to bed.

SILVA left for work around 5:30-5:40 AM and continued communication with McKenzie. SILVA left the house in uniform in attempt to convince CAPPS nothing was wrong and that was simply his routine. SILVA and McKenzie texted and they spoke on the phone every fifteen minutes or so. CAPPS fell asleep around 8:30 AM. McKenzie and Tara told SILVA just before he fell asleep, he was slurring his words. Once CAPPS fell asleep, they grabbed a few things and went

to the Metropolitan-Nashville Police Department Hermitage Precinct. McKenzie and Tara were in the process of getting an order of protection and warrants were obtained but they didn't know when the warrants would be served.

Christmas Day CAPPS was out of it and was basically asleep Christmas morning while they opened gifts.

In total, SILVA observed CAPPS point a weapon towards them or the dogs between ten and fifteen times. SILVA believes CAPPS wanted to kill himself but also wanted to take their lives as well. He believed CAPPS wanted to die before he went to jail because going to jail was the end of his career.

SILVA believed that if he contacted law enforcement while CAPPS was putting the guns away, he would just return to the bedroom and retrieve the guns. CAPPS said if anyone called the police, he was going to shoot everyone. SILVA was hoping when CAPPS put the guns away that he was going to sleep and would "sober up". He thought CAPPS was having a drunken/drugged rampage. As soon as CAPPS went to sleep, Tara and McKenzie went to Hermitage Precinct. SILVA has no knowledge of Tara having an affair if she was. CAPPS accused Tara of both having a "lesbian relationship" with her best friend and also a sexual relationship with SILVA, neither of which made sense.

SILVA was not familiar with guns in the drawer in the upstairs bedroom where he and McKenzie sleep.

When SILVA left the residence, he went to work at TBI headquarters. He continued communicating with McKenzie by calls and text messages. McKenzie told him she could hear Tara and CAPPS talking in the bedroom after he left. When the news reported the incident McKenzie called SILVA and he was released from work. He went to the Metro-Nashville Police Department Family Safety Center to be with McKenzie and Tara. They spoke with victim-services personnel. CAPPS's stepmother Michelle Capps was at the family safety center later that evening along with a Chaplain.

CAPPS had a surveillance camera in the living room and one in the driveway. SILVA is not sure if the living room camera works but if so, it would have recorded the entire incident. CAPPS is the only one with access to the surveillance system on his phone.

Once CAPPS woke up and realized McKenzie, Tara, and the dogs were gone, CAPPS texted McKenzie and instructed her to call him within five minutes. This was followed by a video of him pointing a gun at her bed. SILVA told her to ignore the texts. Tara also received a text from CAPPS demanding her to call him within five minutes. This was followed by a video of CAPPS using a hatchet to destroy a spinning wheel Tara received from her great grandmother. In that video, sirens can be heard in the background.

The interview was concluded at 3:09 PM. The information above is meant to be a summary only and not intended to be an exact transcript of the interview. A digital copy of the above-mentioned interview will be maintained by the case agent in his working case file.

When asked if they ever spoke to CAPPS, ELIZABETH advised that she had, and she had an unpleasant interaction with him. She felt he was very pushy. ELIZABETH advised this happened a while ago. SA Reed asked ELIZABETH and ROSA MACIAS if they observed any strange behaviors from the residents recently, and both ELIZABETH and ROSA MACIAS advised on January 3rd and 4th, 2023, they saw CAPPS pacing and texting outside of their house. They advised CAPPS was wearing plaid pajama pants with a black jacket on. CAPPS appeared to have had a lot going on.

SA Reed asked ELIZABETH and ROSA MACIAS who they have seen living at CAPPS's house and they advised two other females, one older and one younger. They did not interact with them though. On Saturday, January 7, 2023, at approximately 11:55 AM Special Agent (SA) James Scarbro and SA Chris Houk with the Tennessee Bureau of Investigation (TBI) interviewed ASHEY KENDALL COON at the TBI Headquarters building located at 901 R.S. Gass Blvd., Nashville, Tennessee. Also present for this interview was his attorney, John Brown. After signing a waiver and agreeing to speak with agents about the use of force incident, COON provided the following information. This interview was audio recorded and that audio will be kept in the case agents investigative working file and a copy given to the District Attorney's Office. Below is a brief synopsis of the interview:

COON advised that he has worked for the Metro Nashville Police Department for approximately 15 years. He is a full-time member of the Special Response Tactical team (SRT). He has been on the SRT for about 5 years.

COON explained that he was at his office on Stewarts Ferry Pike when he was notified by his lieutenant that patrol might have a situation that would require SRT. COON explained that as the day progressed, he received more information that there had been a hostage situation the previous night and the suspect was MARK CAPPS. COON said he was told that CAPPS allegedly held his wife and stepdaughter hostage for several hours the previous night with one or two guns. COON said he understood that the suspect fell asleep, and the two victims were able to escape and go to the police.

COON said he and the team were informed at some point that the detectives were going to get warrants, so he went to a staging area near which was a school parking lot. He said the plan was further developed at the staging area, and there were some other officers watching the house to see if CAPPS left or came outside. One of the teams reported that the suspect came out of the house on the back deck doing something but went back inside.

COON advised that he was tasked to be cover for the breaching team that would go to the front door. COON advised they were informed warrants were obtained for kidnapping and aggravated assault at that time. COON explained that the plan was to covertly approach the front door and place the charge on the door and then retreat to an area of cover. At that point, the rest of the team would come up in the large SWAT vehicle and typically that is when the team would begin commands and directions to exit the structure informing the suspect that police had surrounded the home.

COON explained that he and the two breachers (Rader and Brewer) got out of their vehicles and approached the house. COON said he scanned the door and windows as they walked up to the front door. COON said he saw a storm door that was outward opening, and what appeared to be a light metal skinned door that was hinged on the right and opened inward. He said it appeared to be closed. COON said he was on the left side of the door and the two breachers were on the right side of the door where the hinges were located. COON said he initially thought he saw the interior door move, because it was like someone was looking through the peephole. He said he tried to see if he could determine if a shadow was cast in the peephole where sometimes people look through.

COON said he then looked at the crack of the door, while Officer Rader was kneeling to place the charge which was about the time he saw the inside door begin to open. COON said his natural response was to yell commands and he yelled "show me your hands". He said the door came open and from that moment COON said he saw the handgun and it was pointed directly at him and the other two officers. COON said he could not see the suspects left hand, and he again yelled "show me your hands". COON said he realized at that point that the suspect saw him and his partners, was not complying with commands, and the gun never changed position. COON described the gun as being about 5 or 6 feet away from officers and the suspect was pointing the gun from his waist area with the barrel toward officers. COON said it appeared to him that CAPPS finger was not on the frame but inside the trigger guard. He said the gun was pointed at him, a finger on the trigger and the only thing that had not happened yet was pressing the trigger. COON said he believed that CAPPS was going to shoot him and his partners and therefore fired his rifle. COON stated he believed he had to fire in order to protect him and his partners life.

COON said CAPPS began to fall back and at the same time the door began to close as he fell. COON said he fired about 4 rounds. COON said he stopped shooting because CAPPS was falling, and he lost a good visual on where he was. (Meaning he could not see where he was shooting at that point) COON said he and Officer Rader and Brewer got the door open and made entry. He said his fear was that CAPPS was still able to shoot him and other officers and therefore still a threat. COON said he cleared to the right and saw CAPPS who did not appear to be a threat at that moment. COON said he ordered him to show his hands again.

COON said an order to continue a protective sweep of the house was given and he helped clear the remaining portions of the house. He said CAPPS was removed to the outside where other officers provided medical aid. After the house was cleared he went outside, and he waited for further direction.

Below is a brief synopsis of the interview:

RADER advised that he has been with Metro Nashville Police Department for almost 23 years. He is a full-time member of the Special Response Team (SRT).

RADER explained that he was at the office when he was first notified by his leadership that SRT would be needed for a mission. He said a staging area was established at a school down the street from and they waited for the arrest warrants to get signed.

RADER said he was informed that the suspect held his wife and stepdaughter hostage at gunpoint in the middle of the night. At some point the victims got out and went to Hermitage precinct to report the incident. RADER stated that the team was informed the suspect was armed and had made threats to shoot anybody or police if they came to the house. RADER advised that the team had developed their plan and around 2:00 PM when they were informed the warrants had been signed.

RADER advised that he went to the front of the house with Officer COON and Officer Brewer. COON was cover, Brewer was the assistant breacher, and he was breacher. RADER stated that COON stepped up on the porch in front of him and started holding cover on the door. RADER said he stepped to the right and knelt to place the charge on the door. He said it seemed like immediately when he touched the outer door, the interior door opened. RADER said he heard COON yell, "let me see your hands", so he repeated it. RADER said as he looked up, he saw the revolver. As RADER said this, he demonstrated how the gun was pointed with his hands and that it was pointed at him. RADER said he had made up his mind that he would have to shoot this guy because he was pointing a gun as officers, and before he did COON fired. RADER said the suspect had fallen down behind the door and so he did not shoot.

RADER explained that the plan was to place a breaching charge on the front door at the same time a second team would place a charge on the back door. After the charges were placed, he said the plan was for officers to then move about 50 ft away to a position around the corner of the house. Once all the charges were placed, the SRT would then conduct announcements and call outs of the suspect.

RADER repeated that the revolver was pointed at the officers, and it was "point blank" and he could see the barrel. RADER said after Officer COON fired, they attempted to get the door open. He said he could hear the suspect moaning, so he was concerned the suspect was still a threat and could shoot through the door. RADER said they made entry through the front door and the suspect was laying on the ground. He said he did not see the pistol at that point but glanced briefly then moved past him to clear the rest of the house.

RADER further explained that in his mind, the best he could recall, was that the suspect kind of held the gun at a retention kind of position near his hip and close to his body. He said he believed the gun was already pointed in the direction of officers as if the suspect knew officers were there at the door. He said the gun was level with his head and he believed the suspect was going to shoot officers.

RADER said he helped clear parts of the house. The suspect was moved outside, and other officers provided medical aid.

BREWER advised that he has worked from the Metro Nashville Police Department for approximately 15 years. He is a full-time member of the Special Response Team (SRT). BREWER said he was at the office but was notified that SRT would be needed to assist with arrest warrants. BREWER explained that SRT members staged at a small school near **Example**. He said some other officers were watching the home and provided some pictures that allowed them to gather intelligence to help make their plan.

BREWER explained that he and other team members had received information that the suspect claimed that he would kill police if they came to his house, so that made him a high-risk suspect and influenced their plan. He explained this meant their plan would be to quietly place breaching tools prior to making announcements. He said this was intended to provide them more of an advantage if the suspect escalated things (such as on second floor with a rifle or if suspect decided to shoot through the door). BREWER said the plan was to place a breaching charge, then retreat to a safe place and make announcements. If the suspect came out and followed commands and was taken into custody then the breaching charges would be removed. BREWER said he knew that the armored vehicle was waiting for them to place charges and then they would have pulled up and announced police and that the suspect had arrest warrants.

BREWER advised that it was roughly 1:00 PM when they began to implement the plan. He was on the team going to the front of the house, and it included Officer COON and Officer Rader. BREWER said Officer Rader was the lead vehicle and stopped a few houses away from and prepared the charges as COON provided cover. Once this was complete, BREWER said the three officers approached the house. He said COON was the first there and stepped up on the porch, and Officer Rader was a little behind them because he was

carrying the charge. BREWER said his job was to assist Officer Rader with placing the charge such as handing him tape or cutters to make it quick.

BREWER said he was securing the tube connected to the charge as Rader was placing the charge when he heard the door open. BREWER said Officer Rader was on his knee and COON was providing cover. BREWER advised that the first thing he saw was a large black revolver coming from around the door. He said that he didn't know what kind of gun, but he recognized it as possibly one of those large shotgun shell kind of guns. BREWER said the gun was pointed at them. He said he had tape in his hand, and he was behind both Officer COON and Rader. He said he heard COON yell "show me your hands", but he is not sure why he yelled that command. BREWER said it was obvious to him that the suspect was pointing a gun, but he figured sometimes that is just the first thing that comes to mind which is to vell because officers are used to commanding show me your hands. He said Officer COON fired approximately 4 or 5 shots and the storm door glass shattered, and the suspect went out of view and the interior door kind of closed. BREWER said Officer COON pushed the door, but all he could see is the suspects legs and not his upper body. BREWER advised that he felt like they were still in danger of being shot. BREWER demonstrated with his hands to agents that he thought the suspect could be still have the gun in his hand and pointing it at the door where officers were positioned.

BREWER stated that he believed they needed to enter the house to ensure the suspect was not a threat. He said as soon as the house was clear, he placed flex cuffs on the suspect. He said he still didn't see the weapon at that time, but he did notice that the house was a mess and stuff was everywhere.

BREWER was asked if the suspect said anything to officers when he opened the door and he said he did not remember him saying anything. BREWER again explained that the suspect was pointing the gun at officers, and he was about 3 or 4 feet away from him, but Officer COON and Rader were closer to the gun. BREWER advised that he did not fire his weapon.

On January 9, 2023, at approximately 1:06 PM, Special Agent (SA) James Scarbro with the Tennessee Bureau of Investigation (TBI) interviewed JUANITA COPELAND in her office located at the purpose of the interview, COPELAND provided the following information. This interview was audio recorded and that recording will be kept in the case agents investigative working file and a copy given to the District Attorney's Office. Below is a brief synopsis of the audio interview and should not be considered a transcript:

COPELAND stated that she is president of the Good Guys Foundation and contacted a friend of hers who works at Metro Nashville Police Department. She said she had been friends with CAPPS for about 15 years. COPELAND stated that she knew CAPPS was in a suicidal place and he had previously promised her that he was ok. She said CAPPS had been progressively more depressed since his father passed away almost two years ago. COPELAND said public perception was very important to CAPPS because he didn't want to diminish his father's reputation. Because of this, she said many people didn't know the demons he faced or the depression. She said CAPPS trusted her and shared with her many problems over the last six months. COPELAND said he was not happy in his marriage and began drinking heavily.

COPELAND explained that CAPPS came to see her toward the end of November, and he was very upset at his father's wife because she was not honoring certain provisions in the Will. CAPPS was supposedly given his father's guitars in the Will but had yet to received them. COPELAND said CAPPS was asking her for advice on what to do about the guitars and she gave him the number to an attorney. CAPPS also complained about his brother because of him constantly calling and asking for money. According to COPELAND, Jimmy Capps gave his son, Jeffrey, money for many years. CAPPS told her Jeffrey was now coming to him for money and threatening the stepmother.

COPELAND advised that CAPPS sent her a picture of himself holding a gun to his head on December 16. He sent this picture to her via text message and COPELAND still had them. COPELAND allowed SA Scarbro to take photographs of the text messages. COPELAND said CAPPS had called her Wednesday night and sent her text messages asking about a job. CAPPS also sent COPELAND a text message around 1:00 PM on the day of the shooting.

COPELAND also advised that she believes CAPPS talked to a band member named Josh who

The Cellebrite UFED software used to examine the evidence allows for the generation of a UFED Reader report. This report allows investigating personnel the ability to examine the readable data without modifying the original evidence. A UFED Reader report was generated and placed on a password protected external hard drive and transferred to a secure media location for examination by investigating personnel.

Examination of the UFED reader report shows text messages sent from 615-**Market (MARK** CAPPS) to 615-**Market (McKenzie** Acuff) on January 5, 2023. These texts are as follows:

- 1/5/2023 at 1:18 PM "Where are ya'll"
- 1/5/2023 at 2:07 PM "We're is fucking Noah?"
- 1/5/2023 at 2:09 PM "Which side?"
- 1/5/2023 at 2:10 PM This was an attached video of a hand pointing a gun at pillows on a bed.



On January 13, 2023, at approximately 3:00 PM Special Agent (SA) James Scarbro with the Tennessee Bureau of Investigation (TBI) contacted COLLEEN WALTERS via telephone at number regarding information that she may have been on the phone with CAPPS on Thursday, January 5, 2023. SA Scarbro had contacted WALTERS by telephone on January 11, 2023, to schedule an interview but was unable to speak with her and left a voice message. After identification and an explanation of the interview, WALTERS agreed to speak with SA Scarbro. This telephone interview was audio recorded and that audio will be kept in the case agents investigative working file and a copy given to the District Attorney's Office. Below is a brief synopsis of the interview and should not be considered a transcript:

WALTERS advised she spoke with CAPPS the night before the shooting incident. She explained that she had known the Capps family for years and was friends with Jeffrey Capps. She said she spoke with MARK CAPPS on Wednesday between 5:00 PM and 6:30 PM about his brother Jeff. The conversation began with text messages explaining that he didn't know details of Jeff's death, but then WALTERS advised that CAPPS called her via Facetime.

She said CAPPS kept asking if she was alone. She said CAPPS was distraught about his brother and talking about some emotional things even though she was aware that they didn't have a good relationship. She said he was talking about how he didn't know how he would have closure with his brother's death because their last words were not good.

WALTERS said it was hard to explain, but CAPPS looked different in a way in his eyes, but he didn't seem drunk. She said he was sad about a lot of loss in his life. WALTERS said he sent her a Facebook message around 1:00 AM the next morning asking her to keep their previous conversation "in trust". WALTERS said he was always very private and friends he had known for years didn't know about CAPPS depression.

WALTERS said during their conversation, CAPPS had told her that he didn't have any money to do a funeral for Jeff. She said she messaged him that she could help and create a go fund me for a memorial. She said CAPPS also told her that he didn't have anybody anymore and wanted her to go to view Jeff's body with him. WALTERS said that kind of shocked her because she had not spoken with MARK CAPPS since his father's funeral two years ago.

Asked if CAPPS told her he wanted to commit suicide like some people have suggested and she said no. WALTERS then said that CAPPS told her the night before when he heard about JEFF that he thought about suicide. WALTERS added how when they were on Facetime, CAPPS told her not to take a screenshot. She said he then went to his side drawer in his bedroom, and she saw many pill bottles. She said CAPPS then pulled out a few guns and laid them on the bed. WALTERS said CAPPS then came back into view of the camera and told her that he "almost did this last night when he heard about Jeff". She said she asked why he was showing her this, and he replied to protect himself. She asked from what, and he responded with burglars and stuff. WALTERS said CAPPS told her that he had sent a picture to his brother of him holding a gun against his head. (WALTERS claimed she has since seen that picture) She said CAPPS told her he did that because he had been going through so much lately and losing everything and he didn't want to kill himself.

WALTERS said CAPPS talked about guitars that his father supposedly left him in the Will, but he had yet to get them. She said CAPPS talked about issues with his father's trust and Will. She said he talked about how much his father's funeral cost.

WALTERS added that after her phone call with CAPPS she did not think he was going to hurt himself, but he seemed strange, and she said it wasn't alcohol because she didn't see any beer bottles. She suggested because of the pill bottles she saw that CAPPS had taken many pills.

On January 5, 2023, the District Attorney General (DAG) for the 20th Judicial District, Glenn Funk, requested the Tennessee Bureau of Investigation (TBI) investigate an officer involved shooting (OIS) that occurred at **Example 10**, Hermitage, Davidson County, Tennessee. The OIS event involved Metro Nashville Police Department (MNPD) SWAT member ASHLEY KENDALL COON. The shooting resulted in CAPPS being struck multiple times and after subsequent first aid attempts by officers and medical personnel, he was pronounced dead at the scene. The incident occurred at approximately 2:00 PM in Hermitage, Davidson County, Tennessee.

SA Scarbro was the assigned case agent for this investigation. SA Chris Houk, SA Andy Vallee, and SA Eric Reed were present and assisted with this investigation.

At approximately 3:35 P.M. SA Houk began to photograph involved officer's uniform COON, as well as two additional Metro Nashville Police Officers present at the time of the shooting BREWER and RADER. At approximately 3:45 P.M. BREWER and RADER provided preliminary information on scene as to the transpired events leading up to and the OIS itself.

On January 18, 2023, at approximately 5:21 PM Special Agent (SA) James Scarbro with the Tennessee Bureau of Investigation (TBI) interviewed JOSHUA SWIFT in an office located at 901 R.S. Gass Blvd, Nashville, Tennessee. After proper identification and an explanation for the purpose of the interview, SWIFT provided the following information. This interview was audio recorded and that recording will be kept in the case agents investigative working file and a copy given to the District Attorney's Office. Below is a brief synopsis of the audio interview and should not be considered a transcript:

SWIFT explained that he is a musician and was hired by the Isaacs in 2020 and worked with MARK CAPPS. SWIFT said he did a lot of "session" work and knew CAPPS from him being an engineer. SWIFT said CAPPS was one of the best and very respected.

The last time SWIFT spoke with CAPPS was 1:10 AM on January 5, 2023. CAPPS called SWIFT using Facetime. Prior to that, SWIFT said he received a text from him on January 4, 2023, at 6:35 PM. The text from CAPPS read, "Got a minute, I need a blunt answer". SWIFT said CAPPS called him on his cell phone (not Facetime) and he was crying. He asked SWIFT how you say something nice about somebody when you can't think of anything to say. SWIFT said he believed CAPPS was talking about his brother because he knew he had just died and knew that the brother had a rough history. SWIFT also stated that he believed based on listening to the slurred speech that CAPPS was inebriated in some form or fashion. SWIFT said CAPPS told him that his brother killed himself out of spite toward him. He said CAPPS' brother did not know where he lived and drove to CAPPS' ex-wife's house to kill himself. SWIFT said CAPPS blamed himself because he wouldn't give his brother money. According to SWIFT, Jimmy Capps paid for everything for Jeff Capps and after his death, Jeff went to his brother, MARK CAPPS, for money. SWIFT said that phone conversation didn't last long and all he did was try to support CAPPS.

SWIFT said CAPPS asked if he could Facetime him on January 4, 2023. SWIFT said CAPPS called him via Facetime and the phone was very close to CAPPS face. He said CAPPS asked him "Tell me not to do it". SWIFT said he wasn't sure at first what CAPPS was meaning. He said he didn't know what he meant, and CAPPS responded with, "Tell me to put it away". SWIFT advised that is when he realized CAPPS was suicidal. SWIFT said he told CAPPS not to do it and that many people loved him. SWIFT said he eventually heard CAPPS appear to unload guns and although he didn't see the guns, he could hear him unloading what sounded

like bullets dropping into a drawer. SWIFT said CAPPS told him he had 11 or 12 firearms he was unloading. SWIFT also said CAPPS asked him not to tell anybody, but he was ok.

SWIFT said he called him again the night of January 4th, using Facetime, and had a bottle that said Woodford on it. This time he said CAPPS was in his studio at his home and not his bedroom. SWIFT said CAPPS was cursing a lot which surprised him. He said CAPPS was concerned that his career was finished and talked about work issues. SWIFT advised that he believed CAPPS was paranoid about things. SWIFT said the phone call ended around 8:45 PM or 9:00 PM, but he was beginning to slur more as the conversation continued.

According to SWIFT, CAPPS had previously shared with him that he overheard his wife talking to a friend complaining that he was a terrible husband. CAPPS was supposedly seeing a therapist. SWIFT said CAPPS insinuated that he had surveillance in the house and that's how he knew his wife's conversations, but he never showed it to him, so he was not sure if it was true. SWIFT also advised that CAPPS was telling people that his wife was having an affair with his stepdaughter's boyfriend.

SWIFT stated that he received a text message from CAPPS around 12:54 AM on January 5, 2023. The text read, "Please keep our conversation in trust. Thx you". At 12:56 AM CAPPS sent another text that read, "Tara woke me up in a panic". SWIFT said CAPPS called him around 1:10 AM via Facetime. He said CAPPS had the phone so close to his face that all he could see was his nostrils and the back of his throat. He said CAPPS' speech was very labored and his eyes were rolled into the back of his head. He said CAPPS was telling him that he tried to text back but couldn't. SWIFT explained that he had never seen anyone that messed up and he thought CAPPS would not be able to wake up. He said it was like CAPPS was trying to talk under water. This conversation ended with SWIFT telling CAPPS that he needed to go to bed.

SWIFT said he never heard back from CAPPS.



Description: Investigative Activity - Review of Video Recordings on 1.5.23

(LE-A) ASHLEY KENDALL COON, W/M, DOB: (O-A) MARK JASON CAPPS, W/M, DOB:

During the course of this investigation, Special Agent (SA) James Scarbro reviewed video recordings of the interactions between MARK CAPPS, his wife, Tara, and his stepdaughter, McKenzie. The videos were recorded by McKenzie Acuff in the early morning hours of January 5, 2023, but the camera is obscured. (For further information refer to Investigative Report #21 of this case file) A review of each video was conducted by SA Scarbro and pertinent information gathered during the viewing/listening of the footage is listed below:

Review of video recorded 1/5/23 at 3:34 AM lasting 23:59

- At 00:20 A man who is identified as Mark is arguing with Tara about turning the alarm system on and the possibilities of drug dealers trying to get into the house.
- At 1:52 Mark states that if he put a gun to his head, nobody would give a "shit".
- At 2:50 Tara tells Mark he can't take Xanax, Ambien, and beer. Mark then replies that Tara knocked Ambien out of his hands.
- At 4:00 Mark asks what time Noah gets up then asks Tara if she is gonna sleep in the bed or on the couch.
- At 4:25 Mark then says, "Tell him to check for a body when he wakes up"
- At 4:29 Tara asks, "Mine" and Mark replies, "No, mine"
- At 6:38 Mark says, "She'll laugh at Noah's jokes, but she will not talk to me"
- At 7:22 Mark says, "She's fucking Noah as far as I know"
- At 10:28 Mark talks about how he thinks Tara has talked to an attorney.
- At 10:55 Mark begins to talk about what he believes are Tara's big plans but explains that she can't touch inherited property.
- At 14:43 Mark then tells Tara that all of what was going on is triggered from Christmas Eve.
- At 15:12 Mark says there are three choices. He says, "One Learn to be a wife" "Two – Go on the way we are" "Three – call the police"
- At 15:28 McKenzie asks, why do we have to call the Police. Mark says, "Because somebody is gonna get shot."
- At 15:56 Mark says, "Noah is the first one to go." Tara then asks what that is supposed to mean, and Mark replied that he is the one who is armed.
- At 16:01 Mark says, "He is the first one I'm going to kill." Tara asks why, and Mark tells her its because he is the one who can protect the two of them. (Tara and McKenzie)
- At 16:55 Mark says he is not happy, and he had plans, so she can be a wife, not be a

- At 17:11 Mark says the last thing he is going to do is turn the gun on himself and before that he was going to shoot every one of her dogs.
- At 17:25 Mark says that he is going to punch the TV.
- At 19:45 Mark says he may get up in the middle of the night and put a bullet through all three of their heads.
- At 19:56 Mark asks if it scares them, and then he tells them to call police.
- At 21:26 Mark says, "Here is what's not going to happen. I have too much pride to put a bullet in my head tonight."
- At 21:45 Mark then says he feels robbed, because if he wants to have a beer in his house he should be able to.
- At 23:08 Mark says if Noah wants to call for back-up, then he has another thing coming, because they are all going down. He then says, "At that point, I don't care."
- At 23:33 Mark says" "this is all because you" and saying that Tara was joking Christmas Eve.
- At 23:59 The video recording ends.

Review of video recorded 1/5/23 at 3:58 AM lasting 1:05:31

- At 5:25 A man who is said to be Mark Capps states that he is very depressed and had been for 6 months. He says he has been depressed since he had to deal with Michelle.
- At 5:40 The man states he would rather kill himself than do something... (inaudible)
- At 7:12 The man says, "if you think me trying to protect you, and McKenzie, and Noah from people who I think Jeff is hooked up with and now he's dead, because you will not turn the alarm on, is wrong, then condemn me to hell.
- At 7:31 the man states, "It occurred to me, is the gun next to my bed loaded" "That's all it was, and you got up and started your shit"
- At 8:29 The man states, "Is Noah up?"
- At 8:50 The man says, "Here's the deal, you got three choices. You can act like a wife" (loud noise" "Either a wife or not, and if you pretend, I'm not interested" "I'm going to wind up in jail, or I'm going to wind up dead"
- At 10:00 The man says, "Tell Noah to think about it before he tries being a hero"
- At 10:48 The man says, "In jail or dead, ya'lls choice, goodnight"
- At 11:35 The man says, "Unless you are paying the mortgage, which you're not, don't ever take a beer out of my hand"
- At 11:50 The man says, "I'm about to start putting holes through the walls"
- At 12:16 There is very loud banging.
- At 14:20 The man is complaining about things in the home that needed to be thrown away.
- At 16:18 Tara says, I'm sorry Mark, and the man replies, "When I start seeing a pattern develop, I just think our marriage is over because you don't give a shit about me."
- At 17:09 The back and forth arguing continues, and Tara says, "I'm a piece of shit like your brother, Jeff" The man, (Mark) replies, "I didn't say you were a piece of shit like my brother Jeff" and he begins hitting something.
- AT 17:19 Tara says don't and McKenzie says, "please Mark".
- At 17:14 More loud banging. (Loud banging and yelling)
- At 17:49 Tara says in a quieter voice, "Go upstairs" (presumably to McKenzie)
- At 18:18 Mark says, "Did she go get Noah up? I'm sure he's up now. He is the first one down."
- At 18:48 Mark says, "Where is Noah. He needs to come out armed because he is the

- At 19:30 Tara says, "Mark please stop"
- At 19:38 Mark says, "Stop what, this?" (An audible metallic click can be heard)
- At 20:32 Both Tara and McKenzie can be heard pleading with Mark to please stop.
- At 20:59 Tara can be heard praying.
- At 21:59 Mark states that all is because of his "piece of shit" brother.
- At 26:50 Mark is talking about whether Tara will act like a wife or be a wife, when he says, "I'll put a fucking bullet through this dogs head"
- At 28:24 Mark complains about his stepmother. Talks about not having his mom, dad, or brother. Claims his career is over.
- At 30:24 After complaining that Tara will not turn on the alarm system, he tells her "Do not push the emergency button on me" He says, "You will be dead before they get here"
- At 30:51 Mark says, "if he shoots me it's murder, if I kill myself its suicide. So, does the insurance money count?" During this you can hear McKenzie yell "please put your gun down"
- At 31:12 Mark says, "Because that's all that matters." "If I kill myself, you get nothing, if he shoots me, its murder, he goes to jail, and you get the insurance money"
- At 31:54 Mark says, "Wake Noah up, and he will be the one to murder me"
- At 33:19 Marks says, "Every single bill is on me"
- At 33:35 Mark is talking about how much money he has to make and then it sounds as if he moves and says, "To make her happy". McKenzie says, "Mark, please" Mark responds with, "It's not cocked"
- At 35:12 Mark asks, "McKenzie what do you care about me"
- At 36:05 Marks asks, "Where's your boyfriend?" McKenzie responds that he is in the bed. Mark says, "Get him up"
- At 36:21 Mark says, "I'm in a mood, someone is gonna die"
- At 38:45 Mark states, "I told you the order of importance. Noah goes down first, then you, then McKenzie, then the fucking dogs, then myself. That is where I've been at."
- At 41:51 Mark states that he has two live guns.
- At 42:33 Mark tells McKenzie to go wake him (Noah) up. Mark says he doesn't care about his life anymore. He tells McKenzie to go wake Noah up, tell him to put everything on, and they will talk. He then said, "We'll make it a hostage situation"
- At 43:03 Mark says he is going to count to 10 and then he will do it himself. He then begins counting.
- At 45:33 Mark says, "If Noah puts a radio call to anybody, everybody is dead."
- At 46:30 Tara says, "you love me so much you want to shoot me?" Mark responds, "No, I'm going to shoot Noah"
- At 47:55 Mark calls out Noah's name, and he responds, "Yea.". Mark asked him if he was packing, if he had his radio on, or if he had called anybody.
- At 48:17 Noah asks Mark why he had guns out.
- At 48:38 Mark says, "Uncocked, please come down."
- At 49:16 Mark tells Noah to please come down. Noah says put the guns down. Mark says no.
- At 49:36 Noah says, "I don't feel comfortable with the guns." Mark says you're the first one to go.
- At 50:48 Mark begins counting. McKenzie says ok Mark we are down here.
- At 52:06 Marks says, "Noah". There are some metallic sounds and then Mark says, "Empty" McKenzie asked about the other one, and Mark stated that as soon as he emptied that one, Noah would call the police.
- At 53:08 Mark then explains again that he had been going through depression the last

six months. He talks about dealing with Michelle over his dads' possessions.

- At 54:00 Mark continues to complain about work, and mentions going to Norway for Thanksgiving, complains about his birthday.
- At 55:08 Mark talks about having a huge blow out with his brother two days after his birthday.
- At 56:06 Mark is explaining that he woke up and checked for his revolver, then stops and asked, "Where is the revolver?"
- At 56:47 Mark tells them he was making sure they were protected.
- At 57:35 Mark states that he has had the worst month since 9/11.
- At 58:50 Mark states that he refuses to spend the rest of his career working on bad shit. He said he would rather work at Starbucks or be in the ground.
- At 59:45 Tara apologizes and said she misunderstood what he was doing. McKenzie also apologizes.
- At 59:59 Mark says, "Off the record, night before, it was going to be me."
- At 1:00:40 Mark says he didn't mean to scare any of them, but she (Tara) took a beer away from him.
- At 1:01:43 Mark said two nights ago he was done, but then Jeff did what he did and now he has to deal with his stuff.
- At 1:02:59 Mark says, "I don't know what you are required to report" Noah says, "I'm not required to report anything." McKenzie then tells him that she will make sure he doesn't report anything if he doesn't want him to.
- At 1:03:47 Mark blamed Tara for not getting money to give him for the house and not helping to pay the mortgage.
- At 1:05:31 Mark is continuing complaining when the video recording ends.

On February 1, 2023, Special Agent (SA) James Scarbro met Detective Mike Roland at the Metro Nashville Police Department Headquarters office located at 600 Murfreesboro Pike, Nashville, Tennessee. The purpose of this meeting was to obtain the Metro Nashville Police Department (MNPD) case files for case number 23-008879.

Detective Roland provided SA Scarbro with an 15GB USB electronic storage device which contained a case summary/incident reports, officer and investigative supplemental reports, CAD reports, Audio files, Fire/EMS reports, domestic violence report, and the arrest warrants related to CAPPS.

The digital storage device contained 37 officer supplemental reports that included the report from SGT Jonathan Frost explaining the operation SRT intended to implement prior to the shooting.

The audio files included on this USB contained the multiple radio transmissions from that day including the audio interview between Tara Capps and McKenzie Acuff with MNPD detectives. During this interview, Capps and Acuff explain and describe what happened between them and MARK CAPPS in the early morning hours of January 5, 2023, at Hermitage.

Due to the voluminous amount of records associated with MNPD case file 23-008879, these records will be retained in the case agent's working case file and copies provided to the District Attorney's Office upon request.

The OIS event involved Metro Nashville Police Department (MNPD) SWAT member ASHLEY KENDALL COON. The incident occurred at approximately 2:00 PM in Hermitage, Davidson County, Tennessee.

Special Agent (SA) James Scarbro arrived at approximately 3:18 PM and made contact with Special Agent in Charge (SAC) Joe Craig. Other TBI agents present at that time were SA Andy Vallee and SA Eric Reed. SAC Craig explained that Metro Nashville Police Department (MNPD) representative Lieutenant Brent Gipson reported that the Special Response Team (SRT) had been requested to serve arrest warrants for CAPPS. SA Scarbro learned that Tara Capps, McKenzie Acuff, and Noah Silva were in the home very early Thursday morning (3:00 AM), when CAPPS gathered everyone in the living room and held them at gun point refusing to let them leave or call anyone. CAPPS was reportedly drinking and taking medications and threatening to kill them or anyone who came to the house, but he eventually fell asleep giving them time to leave and go to the police department. SA Vallee obtained copies of the four arrest warrants charging CAPPS with Aggravated Assault and Kidnapping and provided those to SA Scarbro.

Initial reports were that three members of the SRT were at the front door of when CAPPS opened the door and pointed a pistol at officers. The three officers were Officer ASHLEY KENDALL COON, Officer Tim Brewer, and Officer Jason Rader. Officer COON is the officer who fired his weapon.

At approximately 3:35 PM, SA Chris Houk began taking photographs of the crime scene and officers' uniforms.

At approximately 3:45 PM SA Scarbro attempted to take statements from officers COON, Brewer, and Rader but all three declined until they could speak with their attorney's. Officer's Rader and Brewer agreed to provide limited information to agents processing the crime scene with their attorney present, Jack Byrd, so that agents had an understanding of exactly where the shooting took place and what evidence items may be present and required collection.

At approximately 4:10 PM SA Scarbro collected the rifle belonging to Officer COON for firearms testing. A property receipt was prepared and documented the collection.

While agents were working the crime scene at **Exercise Content of Section**, SA Kendall Henderson interviewed Tara Capps and McKenzie Acuff at approximately 4:19 PM while they were at the Metropolitan-Nashville Police Department (MNPD) Family Safety Center located at 610 Murfreesboro Pike in Nashville, Tennessee.

At approximately 4:30 PM SA Reed began conducting a neighborhood canvas to collect any witness statements.

At approximately 4:34 PM, SA Houk, SA Vallee, and SA Scarbro began marking and collecting evidence items from the crime scene. After evidence items were marked, the Metro Nashville Community Oversight (MNCO) Board members requested to walk through and see the crime scene. SA Scarbro stood at the edge of the crime scene tape and pointed out evidence items to Jill Fitcheard and MNCO investigators. (Refer to the MNPD crime scene log which documented all who entered the crime scene tape)

At approximately 4:34 PM SA Houk, SA Scarbro, and SA Vallee began processing the crime scene after a signed consent to search form was completed by SA Kendall Henderson. SA Houk took overall photographs of the front exterior of the home, front lawn, and overall photographs of the interior of the home. Evidence markers were placed for the following pieces of evidence:

At approximately 5:00 P.M. the Medical Examiner (Megan Whitesell) arrived on scene and collected the body of CAPPS. At this time preliminary photographs were taken of CAPPS inside Nashville Fire Department ambulance.

At approximately 5:45 PM SA Houk, with assistance from SA Scarbro and SA Vallee, completed processing the crime scene. At approximately 5:50 PM SA Scarbro locked the front door of and released the crime scene to MNPD Officers.

On Thursday, January 5, 2023, at approximately 6:25 PM SA Scarbro received a series of emails from Lieutenant Samuel Tetterton from the Metro Nashville Police Department (MNPD). The emails contained a purpose release form for signature and a link to download body worn camera video from Officer's COON, Rader, and Brewer showing the events of the officer involved shooting at

On Friday, January 6, 2023, at approximately 9:50 AM SA Scarbro submitted 4 fired cartridge casings and 1 Colt rifle (S/N **Control**) to the Nashville Crime Lab for forensic analysis. The Taurus revolver (confirmed CAPPS as owner) was submitted to the MID CID vault for storage.

On January 6, 2023, at approximately 11:30 AM SA Scarbro returned a phone call to Tracey West after he had telephoned the Metro Nashville Police Department (MNPD) advising that he had information concerning this investigation. West advised that he was friends with CAPPS brother who was found deceased on 1/3/2023 and knew that CAPPS and his brother had been arguing.

At approximately 12:35 PM Special Agent (SA) James Scarbro attended the autopsy of MARK JASON CAPPS.

At approximately 2:33 PM TBI agents interviewed Zachery Silva.

At approximately 4:04 PM SA Scarbro and SA Henderson met with Tara Capps to conduct a forensic extraction of her cellular phone. The purpose was to obtain text messages and video sent to her by CAPPS on that day.

On Saturday, January 7, 2023, at approximately 11:55 AM TBI agents interviewed Officer ASHLEY KENDALL COON.

On Monday, January 8, 2023, at approximately 8:48 AM TBI agents interviewed Officers Tim Brewer and Jason Rader.

On Tuesday, January 9, 2023, at approximately 1:06 PM SA Scarbro interviewed Juanita Copeland who advised she was friends with CAPPS and knew that he was upset over his late father's estate. She also provided text messages and a photo from December 16th where CAPPS sent her a picture of him holding a gun to his head claiming he just had an argument with his brother.

Between January 9, 2023, and January 17, 2023, SA Scarbro obtained multiple reports from different agencies that included CAD reports, NFD incident reports, MNPD incident reports, as well as radio and phone recordings related to this incident.

On Friday, January 13, 2023, at approximately 3:00 PM SA Scarbro interviewed Colleen Walters who advised she spoke with CAPPS the night before the shooting.

On Wednesday, January 18, 2023, at approximately 5:21 SA Scarbro interviewed Josh Swift who advised he spoke with CAPPS multiple times in the days leading up to the shooting. On January 4, 2023, Swift said CAPPS called him via Facetime and stated, "Tell me not to do it". He said he didn't know what he meant, and CAPPS responded with, "Tell me to put it away". Swift advised that is when he realized CAPPS was suicidal. Swift also said CAPPS asked him not to tell anybody, but he was ok. He advised that he received a text message from CAPPS around 12:54 AM on January 5, 2023. The text read, "Please keep our conversation in trust. Thx you". At 12:56 AM CAPPS sent another text that read, "Tara woke me up in a panic". Swift said CAPPS called him around 1:10 AM via Facetime. He said CAPPS had the phone so close to his face that all he could see was his nostrils and the back of his throat. He said CAPPS'

speech was very labored and his eyes were rolled into the back of his head. He said CAPPS was telling him that he tried to text back but couldn't.

On Thursday, January 19, 2023, SA Scarbro conducted a detailed review of the video/audio recordings of CAPPS made by McKenzie Acuff in the early morning hours (3:30 AM) of January 5, 2023. CAPPS can be heard on the recording claiming that he is going to kill Tara, McKenzie, Zachery, and the dogs. CAPPS said he would then kill himself. At certain times during the recording an audible metallic clicking sound can be heard. CAPPS can also be heard saying if the boyfriend shoots him, then its murder, but if he kills himself it is suicide and then asks what that means about the insurance.

On February 1, 2023, SA Scarbro received the Metro Nashville Police Department (MNPD) file for case number 23-008879 which contained case summary/incident reports, officer and investigative supplemental reports, CAD reports, Audio files, Fire/EMS reports, domestic violence report, and the arrest warrants related to CAPPS.

On February 2, 2023, SA Scarbro collected items from the medical examiner's office. These items included a set of keys, white metal ring, blood spot, hair, nail clippings, Palm print card, Fingerprint card, blue pants, blue shirt, blue undershorts, three bullet (projectiles), and 1 envelope with "foreign debris from left arm".

It should be noted that this report serves as only a synopsis of events surrounding this investigation. For detailed information concerning this investigation refer to Investigative Reports and Related Items submitted to this case file.

PATHOLOGIC DIAGNOSES

- I. Gunshot wounds of the torso (3):
 - A. Entrances: Left axilla, left side of the chest (lateral), and left side of the chest (medial).
 - B. Apparent range of fire: No soot or gunpowder stippling surrounding any of the wounds.
 - C. Cumulative injuries: Perforations of the left side of the chest and left axilla, perforations and fractures of the left anterolateral second through fourth ribs and the left anterior sixth and seventh ribs, perforations of the left upper lung lobe, left lower lung lobe, left lower lung lobe bronchus, pericardial sac, left atrium of the heart, aorta, graze of the ninth thoracic vertebral body, right lower lung lobe, left hemidiaphragm, right hemidiaphragm (x2), spleen, stomach, large intestine (with a large defect through the transverse large intestine), small intestine, mesentery, liver, right adrenal gland, perforation and fracture of the right posterolateral tenth rib and perforations of the intercostal muscles between the right lateral eleventh rib, and penetration of the soft tissues of the right side of the chest and back; bilateral hemothoraces, hemopericardium, and hemoperitoneum.

I hereby certify that I, Shannon M. Crook, M.D., have performed an autopsy on the body of Mark Capps on January 6, 2023 at 10:25 a.m. at the Center for Forensic Medicine. The purpose of this report is to provide a certified opinion to the County Medical Examiner and District Attorney General. The facts and findings to support these conclusions are filed with the Tennessee Department of Health. The autopsy was performed in the presence of Ashly Cordero Rivera, M.D.

EXTERNAL EXAMINATION:

The body is identified by tags. Photographs, fingerprints, palm prints, and bilateral fingernail clippings and clippers are taken.

When first viewed, the body is clad in a previously cut blue shirt, previously cut blue plaid pants, and blue underwear. The hands are bagged. A zip tie handcuff is around the left wrist. A white metal ring is around the left fourth finger. A key chain containing multiple keys is received with the body. All clothing and personal items are retained for law enforcement retrieval.

The body is that of a well-developed, well-nourished white male whose appearance is compatible with the stated age of 54 years. The body, when nude, is 183.5 pounds and 70.5 inches long. The calculated body mass index is 26 kg/m². There is good preservation in the absence of embalming. The body is cool due to refrigeration, rigor is fully developed, and there is well-developed, fixed posterior lividity.

The scalp hair is gray, wavy, and of a short length. A gray beard and mustache are on the face. An average amount of body hair is in a normal male distribution. The irides are blue, the corneae are clear, and there are no petechiae of the bulbar or palpebral surfaces of the conjunctivae. The ears, nose, and lips are normally developed. The teeth are natural and in fair condition. The frenula are intact. The neck is normally developed. The chest is symmetrical, and the abdomen is mildly protuberant. The external genitalia, anus, and perineum are unremarkable. The penis is circumcised, and the testes are descended into the scrotum. The extremities are well-developed and symmetrical. The fingemails are elongated and intact. The back is unremarkable.

IDENTIFYING MARKS AND SCARS:

None.

EVIDENCE OF THERAPY:

A nasopharyngeal airway adjunct protrudes from the right nostril. Electrocardiogram leads are on the torso. Duct tape overlies a wound on the medial left side of the chest ("Gunshot Wound 'C"). A tourniquet is around the upper left arm. Gauze packing material is within "Gunshot Wound 'A" on the left axilla.

EVIDENCE OF INJURY:

I. Gunshot Wounds of the Torso:

Three gunshot wounds are on the torso and will be described below by anatomic location and without regard to sequence or severity. All measurements and descriptions are given with the body in the standard anatomic position. The three wounds on the torso have overlapping wound paths, and the cumulative injuries will be described following the description of each entry wound. Given the overlapping wound paths, the individual bullets cannot be tracked to a particular entrance gunshot wound.

Entrances:

A. Gunshot Wound of the Left Axilla (Gunshot Wound "A"):

An entrance gunshot wound is on the left axilla, centered approximately 13 inches below the top of the head and 7-1/2 inches left of the anterior midline. The 1 x 1/2 inch ovoid perforation has an irregular thin red marginal abrasion extending from the 11 to 7 o'clock positions of the wound. A 5/8 inch red abrasion is just inferior to the wound (along the 5 to 7 o'clock positions) and a 1/4 inch red abrasion extends obliquely from the 11 o'clock position of the wound. No soot or gunpowder stippling is on the surrounding skin. The wound is previously packed with gauze packing material.

B. Gunshot Wound of the Left Side of the Chest (Lateral Wound) (Gunshot Wound "B"):

An entrance gunshot wound is on the left side of the chest (lateral wound), centered approximately 20-1/2 inches below the top of the head and 4 inches left of the anterior midline. The 5/16 x 5/16 inch perforation has an irregular circumferential red-brown marginal abrasion surrounding the wound. A small purple contusion surrounds the wound. No soot or gunpowder stippling is on the aurounding skin.

C. Gunshot Wound of the Left Side of the Chest (Medial Wound) (Gunshot Wound "C"):

An entrance gunshot wound is on the left side of the chest (mediai wound), centered approximately 22-1/2 inches below the top of the head and 2-1/2 inches left of the anterior midline. The 1/4 x 3/16 inch perforation has a very thin dircumferential redbrown marginal abrasion surrounding the wound. No soot or gunpewder stippling is on the surrounding skin. This wound was previously covered by duct tape.

Cumulative Injuries:

After perforating the skin, subcutaneous tissue, and musculature of the left side of the chest and left axilla, the bullets perforate the ribs and organs resulting in the following cumulative injuries: perforations and fractures of the left anterolateral second through fourth ribs and the left anterior sixth and seventh ribs, perforations of the left upper lung lobe, left lower lung lobe, left lower lung lobe bronchus, pericardial sac, left atrium of the heart, aorta, graze of the ninth thoracic vertebral body, right lower lung lobe, left hemidiaphragm, right hemidiaphragm (x2), spleen, stomach, large intestine (with a large defect through the transverse large intestine), small intestine, mesentery, liver, right adrenal gland, perforation and fracture of the right posterolateral tenth rib and perforations of the intercostal muscles between the right posterolateral ninth and tenth ribs, perforation and fracture of the right lateral eleventh rib, and penetration of the soft tissues of the right side of the chest and back.

Associated injuries include approximately 700 mL and 480 mL of liquid and clotted blood within the right and left pleural cavities, respectively. The pericardial sac is open and contains a small amount of residual blood. The peritoneal cavity contains a small amount of free blood and fecal material.

Recoveries:

- 1. A slightly deformed, apparent small caliber, yellow metal jacketed bullet is recovered from the soft tissues of the right side of the back. The bullet is photographed and sealed in an envelope labeled "Bullet from right back."
- ⁷ 2. A 1/2 x 5/16 inch red-brown abrasion with surrounding purple contusion overlies a palpable bullet on the right side of the chest, centered approximately 24 inches below the top of the head and 8 inches right of the posterior midline. A deformed, apparent small caliber, yellow metal jacketed bullet is recovered from the soft tissues of the right side of the chest. The bullet is photographed and sealed in an envelope labeled "Bullet from under right chest abrasion."
 - 3. A deformed, apparent small caliber, yellow metal jacketed bullet is recovered from the soft tissues of the lateral right side of the chest. The bullet is photographed and sealed in an envelope labeled "Bullet from lateral right chest."

The general direction of all three bullets is left to right, slightly front to back, and slightly downward.

II. Other Injuries:

Numerous scattered red-brown abrasions and superficial partial thickness incised wounds, ranging from 1/16 inch to 1/2 inch, are on the forehead, left side of the cheek, chin, left ear, left side of the neck, left flank, and left shoulder.

Numerous scattered red-brown abrasions and superficial partial thickness incised wounds, ranging from 1/16 inch to 3/16 inch, are on the upper left arm. A few of these wounds contain small fragments of radiopaque foreign material. A representative fragment of gray metal foreign debris is recovered from a wound on the upper left arm. This fragment is photographed and sealed in an envelope labeled "Foreign debris from left arm." Scattered purple contusions measuring up to 3/4 inch are on the left flank.

A 3/4 inch yellow-purple contusion is on the right forearm. A 1/16 inch red abrasion is at the base of the dorsal right second finger. A 1/8 inch orange abrasion is on the dorsolateral right second finger. A 1/4 inch orange abrasion is on the medial left wrist. A 1/4 inch red-brown abrasion is on the dorsal left hand. A 1/8 inch thin red abrasion is on the dorsal left fourth finger. A 3/16 inch purple contusion is on the medial right knee. A 1 inch purple to yellow contusion is on the medial lower left leg.

These injuries, having been once described, will not be repeated.

EVIDENCE COLLECTED: The following items are collected and retained for law enforcement retrieval:

- Pulled head hair
- Blood spot card
- Fingerprint and palm print cards
- Bilateral fingernail clippings and clippers
- Bullet from under right chest abrasion

- Bullet from lateral right chest
- Foreign debris from left arm

INTERNAL EXAMINATION:

BODY CAVITIES: See Evidence of Injury. The thoracic and abdominal organs are in their normal anatomic positions. The body cavities contain no significant adhesions.

HEAD: The scalp, subscalpular area, and skull are unremarkable. The dura and dural sinuses are unremarkable. There are no epidural, subdural, or subarachnoid hemorrhages. The leptomeninges are thin and delicate. The cerebral hemispheres are symmetrical with an unremarkable gyral pattern. The cranial nerves and blood vessels are unremarkable. The brain weighs 1340 grams. Sections through the cerebral hemispheres, brainstem, and cerebellum are unremarkable. There are no hemorrhages of the deep white matter or the basal ganglia. The cerebral ventricles contain no blood. The spinal cord, as viewed from the cranial cavity, is unremarkable.

NECK: The soft tissues and preventebral fascia are unremarkable. The hyoid bone and laryngeal cartilages are intact. The lumen of the larynx is not obstructed.

by CARDIOVASCULAR SYSTEM: See Evidence of Injury. The intimal surface of the aorta is free of significant atherosclerosis. The aorta and its major branches and the great veins are normally distributed. The pulmonary arteries contain no thromboemboli. The heart weighs 360 grams. The pericardium, epicardium, and endocardium are smooth and glistening except for the areas of previously described injuries. There is an increased amount of epicardial adipose tissue. The coronary arterial system demonstrates 50-60% stenosis of the left anterior descending coronary artery by calcific atherosclerotic plaque. There are no thrombi in the atria or ventricles. The foramen ovale is closed. The atrial and ventricular septa are intact. The cardiac valves are unremarkable. The myocardium is dark red-brown and firm, and there are no additional focal abnormalities. The average wall thicknesses measure as follows: left ventricle – 1.2 cm; interventricular septum – 1.4 cm; and right ventricle – 0.4 cm.

RESPIRATORY SYSTEM: See Evidence of Injury. The upper airway is not obstructed. The laryngeal mucosa is smooth and unremarkable. The right and left lungs weigh 270 grams and 230 grams, respectively. The pleural surfaces are smooth and glistening except in the areas of previously described injury. The major bronchi are unremarkable. Sectioning of the lungs discloses a pink, mildly congested parenchyma.

HEPATOBILIARY SYSTEM: See Evidence of Injury. The liver weighs 1650 grams and is covered by a smooth, glistening capsule except for the previously described injury. The parenchyma is red-brown and of a normal consistency. The gallbladder contains approximately 10 mL of yellow-green bile. No gallstones are present.

GASTROINTESTINAL SYSTEM: See Evidence of Injury. The esophageal mucosa is gray, smooth, and unremarkable. The stomach demonstrates the previously described injuries and contains a small amount of brown-green thick fluid. There are no tablets or capsules. The gastric mucosa has normal rugal folds, and there are no ulcers. The small and large intestines demonstrate the previously described injuries and show no additional significant findings. The appendix is present. The pancreas is unremarkable externally and upon sectioning.

GENITOURINARY SYSTEM: The capsules of both kidneys strip with ease to reveal smooth, pale, and slightly lobulated surfaces. The right and left kidneys weigh 100 grams and 110 grams, respectively. The cortices are of normal thickness, with well-demarcated corticomedullary junctions. The calyces, pelves, and ureters are unremarkable. The bladder contains approximately 620 mL of clear yellow urine. The mucosa is gray, smooth, and unremarkable. The prostate gland is unremarkable externally and upon sectioning. The testes are unremarkable externally and upon sectioning.

ENDOCRINE SYSTEM: See Evidence of Injury. The thyroid and left adrenal gland are unremarkable externally and upon sectioning. The right adrenal gland demonstrates the previously described injuries. No additional focal lesions are identified.

LYMPHORETICULAR SYSTEM: See Evidence of Injury. The spleen weighs 100 grams and is covered by a smooth, blue-gray capsule. The parenchyma is dark red with no focal lesions. The cervical, hilar, and peritoneal lymph nodes are unremarkable.

MUSCULOSKELETAL SYSTEM: See Evidence of Injury. The clavicles, sternum, and pelvis have no fractures.

TOXICOLOGY: Blood, urine, and vitreous are submitted for toxicologic analysis. See separate report.

POSTMORTEM RADIOGRAPHY: Postmortem radiographs are taken prior to autopsy and are reviewed.

CONCLUSION:

By history, the decedent is a 54-year-old male who was shot by another person(s) during an interaction with law enforcement who were attempting to serve an arrest warrant on January 5, 2023. Resuscitative efforts were performed, and he was pronounced deceased. An autopsy is performed on January 6, 2023.

Autopsy examination reveals multiple gunshot wounds, as described above. Three bullets and a small fragment of gray metal foreign debris are recovered during the autopsy.


Postmortem toxicology of femoral blood detected ethanol (169 mg/dL), alprazolam (30 ng/mL), dihydrocodeine/ hydrocodol- free (8.2 ng/mL), and hydrocodone – free (25 ng/mL). Ethanol (182 mg/dL) is detected in the vitreous fluid.

Based on the available investigative information, autopsy examination, and toxicologic analysis, it is my opinion that Mark Capps, a 54-year-old male, died as the result of gunshot wounds of the torso. The manner of death is homicide.

Other than the above findings, examination of the specimen(s) submitted did not reveal any positive findings of toxicological significance by procedures outlined in the accompanying Analysis Summary.

Alprazolam (Xanax®) - Femoral Blood:

Alprazolam is a low-dose benzodiazepine used for the treatment of anxiety disorders and short-term relief of anxiety associated with depressive symptoms. Alpha-hydroxyalprazolam is an active metabolite of alprazolam. They share the actions and adverse reactions of other CNS-depressants, Common adverse effects of alprazolam include drowsiness and fatigue.

Reported therapeutic plasma concentrations of alprazolam are proportional to dose given: 3 mg/day produced steady-state levels of 30 ng/mL; 6 mg/day, 60 ng/mL; and 9 mg/day, 100 ng/mL.

In reported cases involving driving under the influence, alprazolam concentrations ranged from 8 - 640 ng/mL. Alcohol greatly enhances the activity of benzodiazepines.

Reported blood concentrations of alprazolam in alprazolam-related fatalities ranged from 100 - 400 ng/mL (mean, 200 ng/mL). In combination with other central nervous system depressants such as ethyl alcohol, alprazolam can become toxic at low concentrations.

Dihydrocodeine / Hydrocodol - Free (Hydrocodone Metabolite) - Femoral Blood:

Dihydrocodeine (6-alpha-hydrocodel) is an opiate analgesic. It is available as a therapeutic agent (in products such as Synalgos-DC® and DHC Plus®) for oral use and can be formed in vivo as a metabolite of

This analyte is metabolized by N-demethylation to nordihydrocodeline and by O-demethylation to dihydromorphine; these analytes may be found in very low concentrations in blood after the use of the parent drug. Higher concentrations of these metabolites (and their conjugates), as well as dihydrocodeine are eliminated into the urine.

The reported peak plasma concentration of dihydrocodeine following a single 30 mg oral dose approximates 70 ng/mL (at 1.6 hours) and after a single 60 mg oral dose is between 150-200 ng/mL (within 2 hours).

A lethal dose of dihydrocodeine in naive users is estimated at about 0.5 g; opiate abusers may tolerate as much as 5 g. In fatal overdose cases involving dihydrocodeine, postmortem blood concentrations have been reported to exceed 7000 ng/mL.

5 Hydrocodone - Free (Vicodin®; Zohydro®) - Femoral Blood:

> Hydrocodone is a DEA Schedule II semisynthetic narcotic analgesic. It is similar to codeine in analgesic activity and is also widely used in cough syrups for its antitussive activity. This analyte is reported to be highly addictive. For relief of pain, hydrocodone, as the bitartrate salt, is only available in oral form in combination with non-opiate drugs, e.g., acetaminophen. Active metabolites of hydrocodone include hydromorphone and hydrocodol (dihydrocodeine). Normal adult oral dosages range from 5 to 10 mg every 4 to 6 hr. Hydrocodone has also been demonstrated to be a metabolite of codeine.

> After a single oral administration of 10 mg, mean peak serum levels of 20 ng/mL were reported at 1.5 hr; levels dropped to 7 ng/mL at 8 hr.

Hydrocodone is reported to be more toxic than codeine. In overdose, it produces the same manifestations as Conternation of the conter other opiates including: drowsiness, sedation, respiratory depression, coma and death. In reported overdosage, post-mortem blood levels ranged from 130-7000 ng/ml.
