**Narrative:**

On 11/7/2025 at 7:35am, ANDRE LAMORE BROOKS was interviewed by the reporting agent at the Greyhound Station at 709 Rep. John Lewis Way, Nashville, TN, in Davidson County. After proper identification and explanation of the purpose for the interview, BROOKS voluntarily provided a statement. The recording has been saved and is in the custody of SA Moseley and will be released to the District Attorney upon request. The following is a brief synopsis of the interview:

Mr. BROOKS is a homeless individual that did not know the gunshot victim. He was around this individual for approximately an hour and a half before the shooting occurred when they were both outside of the Greyhound Station. BROOKS stated that this person seemed to be depressed and this individual stated that "something bad was going to happen."

Mr. BROOKS observed the officer-involved shooting and was near the shooting when it took place. Mr. BROOKS stated that the gunshot victim had a backpack with him when police arrived on scene. Mr. BROOKS stated that the gunshot victim was in the road in front of the Greyhound Station when police arrived in their police vehicles. He stated that the gunshot victim ran toward police, told police that he had a gun and reached his hand into his bag. Mr. BROOKS stated that police gave commands to this individual and shot him as he started to pull his hand out of this bag. He stated that police began to administer CPR after they shot him. Mr. BROOKS heard around 6 shots fired during this incident.

Mr. BROOKS stated that he believes this individual was on a suicide mission.
