Maxwell, was conducting a walking patrol standing at the entrance to a parking lot next to Jason Aldean's at [REDACTED] when I observed EDU officers speaking with the arrestee in front of the entrance to Jason Aldean's. I then heard a commotion and I looked up, where I observed the EDU officers begin to attempt to escort the arrestee down to the ground. I then ran over and the EDU officers had the arrestee down on the ground on his stomach attempting to get his hands behind his back. I dropped down and grabbed the arrestee's right arm and forced it behind his back, where EDU officers were then able to get the arrestee's hands in handcuffs.

When I arrived on scene EDU Officers had taken Mr. Driscoll to the ground and Mr. Driscoll was refusing to lay on his stomach so officers could place his hands behind his back. I grabbed Mr. Driscoll's hips and pushed on them until he was proned out on his stomach. I noticed that my glasses had been knocked off and were under Mr. Driscoll. EDU Officers were able to take Mr. Driscoll into custody with out further incident.
